

Terms & Conditions

1. PROVISION AND SERVICE OF EQUIPMENT:

Albatross International Pte Ltd will provide water dispensers and bottles, hereafter called 'equipment' and ensures that it is in good operating condition. Albatross International Pte will perform free of charge all repairs of technical malfunction of the equipment and/or replace any part or the whole of the equipment at its own discretion.

2. USAGE:

The Customer shall use all equipment provided by Albatross International Pte Ltd for the sole purposes of dispensing spring water supplied by Natural Springs Australia. Bottles and dispensers cannot be used for any other liquid or materials other than the spring water supplied by us. Should such an incident occur Albatross International Pte Ltd reserves the right to cancel the agreement and the customer will be liable for any damages caused by the storage of unauthorized liquid or materials and might upon its own discretion offset any of these damages from the deposit.

3. OWNERSHIP:

Albatross International Pte Ltd retains the ownership of all equipment provided. The Customer will use the equipment and the spring water for business, personal, domestic or household purposes only.

4. LOCATION OF EQUIPMENT:

The Customer shall keep the equipment in a safe and proper location and keep Albatross International Pte Ltd informed if the equipment is move to another location. Shifting of dispenser by Albatross International Pte Ltd is S\$30.00 per unit per location.

5. MAINTENANCE OF EQUIPMENT:

The Customer shall maintain the equipment in a clean and hygienic condition; any cost for cleaning the dispenser internally or externally shall be for the expense of the customer. The customer also shall ensure that all necessary care is taken to protect the equipment; be responsible for the cost of any replacement(s) and/or repair(s) resulting from fire, theft, loss, damage or any other circumstances beyond the control of Albatross International Pte Ltd. Cleaning of dispenser is S\$50.00 per unit.

6. SECURITY DEPOSIT AND RENTAL:

The Customer shall pay to Albatross International Pte Ltd a security deposit set out on the contract. Albatross International Pte Ltd will charge rental of S\$100.00 per year excluding prevailing gst. If the equipment is lost, damaged or destroyed, the customer will pay the costs of repair and replacement and Albatross International Pte Ltd will be entitled to use the security deposit towards payment of rental and of such costs. Once the equipment is returned to Albatross International Pte Ltd in a satisfactory condition the security deposit less the applicable rental charge will be refunded.

7. RENTAL FREE DISPENSERS

Albatross International Pte Ltd will provide under certain promotional conditions a rental free hot and cold water dispenser. To qualify for a rental free dispenser the customer undertakes to consume a minimum of 36 bottles per year.

8. TERMS OF PAYMENT:

Albatross International Pte Ltd will invoice all purchases on delivery and the customer undertakes to pay any such invoice in term of cheque or cash on delivery basis.

9. TERMS OF AGREEMENT:

This Agreement will continue for the period of one year from the date of signing and shall automatically renew for another one year.

10. TERMINATION:

The contract can be terminated any time by the customer or by Albatross International by giving one month notice (subject to clause 6 and 7).

11. ACTION UPON TERMINATION:

At the expiration or termination of this agreement Albatross International Pte Ltd shall have the right to enter the premises where the equipment is located and remove the equipment without any prior notice being given to the Customer and Albatross International Pte Ltd shall not be held liable for any trespass, damage or otherwise. The customer must pay to Albatross International Pte Ltd or its agent all outstanding fees or invoices. No refund for any unopened bottles.

12. EXPATRIATE CLAUSE:

We understand if you have to leave Singapore. There will be no penalty - provided you have been our customer for a minimum of 12 month. The contract will be terminated. Albatross International Pte Ltd or its agent requires 3 - 5 working days' notice to collect the dispenser, the bottles and to arrange any applicable refundable deposit (subject to clause 6 and 7).

13. INFORMATION CONCERNING CUSTOMER:

The Customer agrees that Albatross International Pte Ltd may obtain a credit report or any information concerning the Customer's personal credit worthiness from any credit reporting agency or any other business which provides such information about the commercial activities or credit worthiness of the Customer.

14. ENTERING YOUR PREMISES UPON DELIVERY

Upon delivery, you may ask our drivers to enter your premises to place the bottles/dispensers at your appointed location. You may do so at your own risk. Albatross does not accept any liability or claim for damages, breakages or missing items (including cash) from within your premises.
